



## LED HIGHBAY & T8 LED WARRANTY

Littil LED Highbays & T8 LED Tubes are covered by a 5-year manufacturer's warranty against defects on workmanship or materials used in the manufacture. The warranty is limited to the replacement or repair of Littil Lamps that become defective under normal usage, as determined by Littil Pty Ltd (Littil). The warranty cannot be excluded under the Australian Consumer Law

### WARRANTY

Littil warrants that Lamps supplied will be free of manufacturing defects and will perform to Littil's specifications subject to the following terms and conditions:

1. **Extent of Warranty:** This warranty extends only to the owner of the property in which the Littil Lamps are installed ("Owner") for the duration of the Warranty Period.
2. **Warranty Period:** This warranty commences on the date of purchase and continues for the benefit of the Owner for three (5) years ("Warranty Period"). Extended warranties are available on request. Where extended warranties are provided, the term of warranty and specific conditions will be detailed on any quotations provided to you by Littil.
3. **Nature and Ambit of Warranty:** If within the Warranty Period either a manufacturing defect is discovered in a Littil Lamp or a Littil Lamp fails to perform to Littil's specifications as a result of a defect in material or workmanship on Littil's part ("Defect") then Littil will, at its option, either repair the Lamps at no cost to the Owner or supply a replacement Lamps on an F.I.S. basis. The replacement lamp will be with the same or current similar model.
4. **Warranty Limitations**
  - (a) This warranty will not apply and, subject to paragraphs 4(c) and (d), Littil will be under no liability whatsoever if the Littil Lamp:
    - (i) has not been installed by a qualified tradesperson, where the law requires installation to be carried out by a qualified tradesperson; or
    - (ii) has been subject to misuse, neglect, negligence or accident; or
    - (iii) has been operated in any way contrary to any operating or maintenance instructions; or
    - (iv) has been improperly handled, installed or maintained, or has been altered or modified.
  - (b) This warranty excludes any other components of any lamp fixtures that is subject to other manufacturers' guarantees.
  - (c) To the extent that the law permits or allows Littil to exclude or limit its liability, Littil under this warranty:
    - (i) accepts no responsibility for loss or damage (including consequential or special loss or damage) howsoever caused (whether by negligence or otherwise) which may be suffered or incurred or arise directly or indirectly in respect of any Defect; and
    - (ii) where warranties or conditions are implied by law, limits its liability to repair or replacement of the lamp.
  - (d) To the extent that the law permits or allows Littil to exclude or limit its liability:
    - (i) Littil's undertaking in paragraph 3 is the sole extent of Littil's liability in respect of any Defect in a light fitting; and
    - (ii) except as expressly provided in this warranty, all terms, conditions, warranties, undertakings, inducements and representations, whether express or implied, statutory or otherwise, are excluded.
5. Littil shall not be liable for and the Customer releases the Company from any claims in respect of faulty or defective design of Goods supplied unless such design has been wholly prepared by the Company and the responsibility for any claim has been specifically accepted by the Company in writing. In any event the Company's liability hereunder shall be strictly limited to the replacement of defective parts in accordance with these Conditions.
6. Subject to these Conditions, all express and implied warranties, guarantees and conditions under statute or general law as to merchantability, description, quality, suitability or fitness of the Goods for any purpose or as to design, assembly, installation, materials or workmanship or otherwise are hereby expressly excluded and the Company shall not be liable for physical or financial injury, loss or damage or for consequential loss or damage of any kind arising out of the supply, layout, assembly, installation or operation of the Goods or arising out of the Company's negligence or in any other way whatsoever.
